TERMS AND CONDITIONS

1. Information on how to enter and prizes form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. Entry is open to all Australian residents aged 18 years and over. Employees (and their immediate families) of the Promoter and agencies associated with this promotion are ineligible to enter.
3. The promotion opens at 16 February 2019 and closes at 2 March 2019 (“Promotional Period”). The draw will take place at Dubbo Regional Council, Corner Darling and Church Streets Dubbo NSW 2830 and the winner will be determined at 9am Monday 4 March 2019. The winner will be notified in writing and by telephone and email within seven (7) days of the draw. The winner’s name will be published on www.dubbo.com.au for 28 days from this date.
4. To enter, individuals must go to www.dubbo.com.au and follow the prompts to the competition page during the promotional period and complete the competition entry form including their full name, postcode, current email address and telephone number and submit the entry as instructed.
5. One (1) entry permitted per person.
6. The Promoter reserves the right, at any time, to verify the validity of entries and entrants (including an entrant’s identity, age and place of residence) and to disqualify any entrant who submits an entry that is not in accordance with these Terms and Conditions or who tampers with the entry process. Errors and omissions will be accepted at the Promoter’s discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.
7. Incomplete, indecipherable, or illegible entries will be deemed invalid.
8. A representative from Dubbo Regional Council will draw the winner randomly. The major prize winner and will win a two day planned holiday for two (2) adults to Dubbo. Prize includes:

 3. Two (2) adult passes to the Dubbo Escape Room (by appointment on Friday 8, Saturday 9 or Sunday 10 March) valued at \$80.00.

4. Two (2) adult passes to the Old Dubbo Gaol (9am – 4pm Friday 8, Saturday 9 or Sunday 10 March 2019) valued at \$40.00.

The minimum total prize pool is valued at up to \$525.00 (including GST) any ancillary costs associated with redeeming the prize are not included. These are the responsibility of the winner.

9. 17. All prize items are valued inclusive of GST and the Promoter takes no responsibility for any variations in item values. The components of the Prize may alter for reasons beyond the Promoter's control. The Prize is not, nor any component thereof, transferable, exchangeable or redeemable for cash. No components of the Prize can be exchanged for other travel or accommodation at other destinations. In the event that any prize item is unavailable, the Promoter reserves the right to substitute a prize item of equal or greater value. Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter (including its respective officers, employees and agents) is not responsible for and excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of: (a) any technical difficulties or equipment malfunction (whether or not under the Promoter's control); (b) any theft, unauthorised access or third party interference; (c) any entry or prize claim that is late, lost, altered, damaged or misdirected (whether or not after their receipt by the Promoter) due to any reason beyond the reasonable control of the Promoter; (d) any variation in prize value to that stated in these Terms and Conditions; (e) any tax liability incurred by a winner or entrant; or (f) use of the prize.

If this promotion is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, the Promoter reserves the right, in its sole discretion, to the fullest extent permitted by law: (a) to disqualify any entrant; or (b) subject to any written directions from a regulatory authority, to modify, suspend, terminate or cancel the promotion, as appropriate.

The Promoter collects personal information ("**PI**") in order to conduct the promotion and may, for this purpose, disclose such PI to third parties, including but not limited to agents, contractors, service providers, prize suppliers and, as required, to Australian regulatory authorities.
